Rules of Entry:

Open to all Ontario based artists, except jurors, their families and those with whom they reside.

Submissions: Works will be juried by CD/DVD. Up to two original works can be submitted for jurying; must have been created in the last 12 months.

Entries will be accepted until 5pm on Monday, January 16, 2012. Entry fee per artist: \$30.

CD/DVD requirements: Entry numbers on the form must correspond with the file names on the CD/DVD. Save files as entry1yourlastname, etc. Images must be 1000 pixels on the longest side.

Entry fee is non-refundable. Payment, in the form of cash, cheque or money order payable to Quest Art Gallery, must accompany entries. Entries with post-dated cheques will not be accepted.

Size: The perimeter of 2-dimensional works accepted into the show, including frame, must not exceed one-hundred and forty-four (144) inches. 3-dimensional work must not exceed three (3) cubic feet.

Presentation: All works accepted to the show must be ready for display. Work must be dry and ready to be hung or mounted. Quest Art Gallery reserves the right to reject unacceptable framing, works not ready to hang or works which are misrepresented on the CD/DVD.

Quest will receive a 30% commission on all sales. All works entered must be available for sale.

Works not meeting the above criteria will not be accepted or presented to the jurors.

All entries meeting the above criteria will be juried and the decision of the jurors is final.

Accepted submissions may be used in print or electronic media by Quest Art.

For results of jurying, please include your email address. Results will not be sent by mail. If you would like your submission returned to you, please enclose a self-address stamped envelope with sufficient postage. Results will be emailed no later than Friday, January 20, 2012. CDs/DVDs will also be available for pick up at Quest Art from March 5-May 5, 2012. After that date, they will be destroyed.

Receiving of selected work will take place at Quest Art on Monday, March 5 from 10 –5pm ONLY. Works will be accepted if they are mailed or shipped (costs incurred are the responsibility of the artist). Please contact gallery to discuss these arrangements.

Unsold, exhibited work must be picked up Monday, May 7, 2012 between 10-5pm.

STORAGE IS NOT AVAILABLE.

Insurance is the responsibility of the entrant. Quest Art is not responsible for work not picked up at the specified time and will assume no responsibility for any loss or damage that may occur during show.

No entry may be withdrawn once it has been accepted and selected work must remain in the gallery for the duration of the show.
